SSC conducts various exams to select the deserving candidates for the post in various ministry and similar departments. **CGL (Combined Graduate Level)** exam is one the test conducted by Staff Selection Board to recruit the candidates for many posts like Assistant Audit Officer, Statistical Investigator, Intelligence Bureau Assistant, Inspector of Income Tax etc are few to name.

Exam's Name: Combined Graduate Level (CGL)

Age Limit Relaxation in SSC CGL 2017:

Below table is showing Age Relaxation Limit for OBC, SC, ST, Physical Handicapped and Ex Servicemen category wise according to reservation system of India. Candidates looking for SSC CGL 2017 Eligibility Criteria, should find their category and age relaxation accordingly in below table.
